## Smilezone Foundation: Electronic 50/50 Rules of Play

1. The lottery will take place during each Raptors 905 game listed here:

Saturday March 10<sup>th</sup>, 2018 at 2:00pm

Saturday March 24<sup>th</sup>, 2018 at 2:00pm

2. All tickets will only be sold to people who are 18 years of age or older.

3. Tickets are 3 for \$5, 10 for \$10, and 95 for \$20

4. Tickets will be available at all events held throughout the building at the at 5500 Rose Cherry Place, Mississauga, ON (Hershey Centre)

5. Tickets will be sold using electronic raffle system supplied by 5050 Central

6. After buying, patrons will be given by the sellers, a receipt with their 50/50 registered numbers from a Random Selection System. No specific numbers can be given as numbers are generated randomly.

7. The winning ticket number will be selected by a Random Number Generation (RNG) system from all raffle numbers sold for the draw for that day/game.

8. The amount of the 50/50 will be announced throughout the game and at the Kiosk.

9. The winning number will be announced by public announcement at event in third quarter.

10. If the patron with the winning number on their ticket is at the game where the number has been drawn, they may then come to the kiosk located at Gate A.

11. If the winner is not in attendance at the game, or does not wish to claim their prize immediately, they may claim their prize by contacting Smilezone Foundation at: (905) 951-2978, or by email at: [jkouroupis@smilezone.com](mailto:jkouroupis@smilezone.com). The ticket may then be brought to Smilezone Foundation's office, located at 557 Chartwell Road, Oakville at an agreed upon time for ticket verification. The winner will then be paid by cheque for the amount posted at the event for which they bought their ticket. Or; the winner may make arrangements to bring the winning ticket to any remaining Raptors 905 game located at Hershey Centre for verification and payment by cheque. Winners must have the original winning ticket and no copies. **All payments will be made by cheque.**

12. The winning ticket holder has **6 months** in which to claim their prize from the date of the draw their ticket was purchase for.

13. The winner must provide his/her name, address and phone number with picture identification for our report sheet.

12. Once the certified winner is verified, and provides identification with photo ID, they will be given a cheque in the amount of the declared prize which is, at minimum, 50% of the total sales for that game. If the winner cannot provide photo ID, then the winning proceeds will be held until such identification can be provided.

14. If no winner comes forward the number will be announced repeatedly over the PA system, and posted on the Smilezone Foundation website ([www.smilezone.com](http://www.smilezone.com))

15. At subsequent events, the number will be posted at each selling station.

16. In the event that no winner comes forward, the winning stub will be kept in a safety deposit box and held for 6 months. After that time period has elapsed the prize will be donated to a charity other than Smilezone Foundation, with the approval of the Alcohol and Gaming Commission of Ontario (AGCO).

17. The following individuals are not eligible to participate in the 50/50 draws:

1. No member, principal officer or paid staff of an applicant organization may be involved, in any way, in the approval of a licence application and/or the management and conduct of a licensed event. For example, a member of a municipal council who is also a member of the applicant organization must refrain from offering an opinion or vote on the granting of the licence, must not sign the application and must not have any direct or indirect dealings or decision-making authority with respect to the licensed event.

2. No person assisting in the conduct and management of a lottery event may have any monetary interest in any card, ticket or bet, or have a chance to win a lottery prize in any way.

3. No designated member responsible for the conduct of the licensed lottery, or volunteers assisting with the lottery, may have any direct or indirect personal financial interest in the funds raised.
